

Indiana Farm Bureau Health Plan 2026 Survey Sweepstakes

If you participate via mobile device, message and data rates may apply.

OFFICIAL RULES: NO PURCHASE NECESSARY TO ENTER OR WIN. You have not won yet.

Eligibility and Sponsorship: This Indiana Farm Bureau Health Plan 2026 Survey Sweepstakes (“Sweepstakes”) is open only to legal residents of Indiana who are at least 18 years old at time of entry. Other restrictions apply. Void where prohibited. The sponsor is Indiana Farm Bureau Members Health, LLC (“Sponsor”), 225 S. East St., P.O. Box 1290, Indianapolis, IN 46206-1290. Employees of Sponsor, its affiliates, subsidiaries, their immediate families and any persons living in the same household, whether or not related, are not eligible to participate. The term “immediate family members” includes spouses, parents, siblings, and children, regardless of where they reside.

Entry Period: This Sweepstakes begins April 15, 2026 at 8:00 a.m. Eastern Time (ET) and ends April 29, 2026 at 12:00 p.m. (“Entry Period”). Entries must be received by 12:00 p.m. ET on April 29, 2026 at the home office of Indiana Farm Bureau, Inc., 225 S. East Street, P.O. Box 1290, Indianapolis, IN to be a valid entry.

How to Enter: During the Entry Period, there are 2 ways to enter.

A. During the Entry Period, complete a survey about Indiana Farm Bureau Health Plans that is sent to you via email or can be found at www.infbhealthplans.com and enter your name and email when prompted. A person may enter only one (1) time. Or, B. Participate without completing the survey by sending a postcard to the Sponsor in care of Mallory Meyer. Please include first name, last name, street address, city, state, zip code, daytime and evening phone numbers, email address and date-of-birth. Please also reference the Indiana Farm Bureau Health Plan 2026 Survey Sweepstakes on the postcard. Postcard entries must be received by 12:00 p.m. ET on April 29, 2026.

Limit one entry per email address and per person. Entries received from any person or e-mail address in excess of the stated entry limit will be void. Entries generated by any automated means and entries made by any means which subvert the entry process will be void. Sponsor and its employees are not responsible for any entries submitted through unauthorized channels or for any incomplete, lost, late, stolen, postage-due, misdirected, mutilated, inaccurate, incomplete, garbled, delayed or illegible entries, memberships, payments and mail, all of which will be void. All entries become property of Sponsor and none will be acknowledged or returned. Sponsor and its employees are not responsible for failure to receive or record entries, memberships, or mail due to human processing errors or transmission or technical failures of any kind.

Prizes: There are two (2) prizes. The prizes are one-hundred-dollars (\$100). Prize retail value is one-hundred dollars (\$100). One prize will be awarded randomly to a member of Sponsor enrolled in the health plans on or after October 2025. The other prize will be randomly awarded to a member of Sponsor enrolled in the health plans between January 2021 and September 2025. A total of two (2) prizes will be awarded.

Drawings/Odds: The winners will be selected on April 30, 2026 at the Sponsor's main office in a random drawing from among all eligible entries collected during the Entry Period. You do not need to be present to win. You may only win one prize regardless of the amount of entries you have in the sweepstakes. All entries, regardless of the mode of entry, have an equal chance of winning. Winners will be notified via email. If the initial winner is ineligible or does not claim the prize within two (2) days, the prize will be forfeited and another winner will be randomly drawn. The prize is non-transferable and no substitution or cash equivalent is permitted. Winners are solely responsible for any federal, state, and local taxes. Odds of winning will depend on the number of eligible entries received, according to the eligibility requirements in the Sweepstakes. Non-winning entries will not be eligible for subsequent drawings.
